Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated February 14, 2023, placed the rating(s) of Ferozepur Foods Energy Private Limited (FFEPL) under the 'issuer non-cooperating' category as FFEPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. FFEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated December 31, 2023, January 10, 2024, January 20, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Incorporated in 2010, Ferozepur Foods Energy Private Limited (FFEPL) was engaged in the processing of paddy to produce basmati rice as well as its by-products like bardana, bran, husk, etc, since the commencement of its manufacturing operations in January-2016. Prior to that, the company was engaged in the trading of rice since FY15. The company operated from a single manufacturing facility in Ferozepur, Punjab. However, in FY18, the company had sold its manufacturing facilities limiting its operations to trading of rice only.
