Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 21, 2023, placed the rating(s) of Shri Venkatesh Trading Company (SVTC) under the 'issuer non-cooperating' category as SVTC had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. SVTC continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated January 07, 2024, January 17, 2024, January 27, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
