#### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated February 13, 2023, placed the rating(s) of Rana Education Society (RES) under the 'issuer non-cooperating' category as RES had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. RES continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated December 30, 2023, January 09, 2024, January 19, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the society

Founded in the year 2005, Rana Education Society (RES) is an educational trust registered under the Society Registration Act 1860 for operating educational institutions. Currently RES operates one school in the name of Delhi Public School, located at Saturna village in Amravati, Maharashtra which is recognized under The Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012. Though the entity was established in 2005 the construction of the project was completed as on July, 2018 and thus FY19 was the first full year of operation. As on September 16, 2019 it operates from nursery to eight standards and has a total seating capacity of around 800 students as against currently 450 students are enrolled. The entity M/s Rana Education Society (RES) has applied for the affiliation to the CBSE Board; however, the same is awaited.
