Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated January 17, 2023, placed the rating(s) of Somula Constructions Private Limited (SCPL) under the 'issuer non-cooperating' category as SCPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. SCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated December 03, 2023, December 13, 2023, December 23, 2023.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Company

Somula Construction Private Limited (SCPL) was incorporated by Mr Somula Venkata Prasad Reddy (Managing Director) and his wife Mrs Venkata Subbalakshmi Somula in the year 2008 as a Private Limited company. SCPL is a Kurnool based company engaged in civil construction works such as laying roads and irrigation works for government organizations covering Road & Buildings Department (R&B) and Panchayat Raj which are procured through tenders. The company is a Class- I contractor. Beside civil construction works, the company is also engaged in trading of coal and steel in Andhra Pradesh region. The company generates around 60% of its total revenues from trading activities and balance 40% from execution of civil construction works.
