Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 13, 2023, placed the rating(s) of Dura Roof Private Limited (DRPL) under the 'issuer non-cooperating' category as DRPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. DRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated December 30, 2023, January 09, 2024, January 19, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Dura Roof Private Limited (DRPL) was incorporated during May 2015 to initiate a colour coated steel roofing manufacturing business. After incorporation the company started to set up a manufacturing unit at Kamrup in Assam and the commercial operation has started from August 2016. The company manufactures Colour Coated & Natural Colour Steel Roofing Sheet & Rolling Shutters with guides and sells in the domestic market. The day-to-day affairs of the company are looked after by Mr. Kishore Kumar Saboo, Director, along with other three directors and a team of experienced personnel.
