Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated April 10, 2023, placed the rating(s) of L-Comps and Impex Private Limited (LIPL) under the 'issuer non-cooperating' category as LIPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. LIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated February 24, 2024, March 05, 2024, March 15, 2024, May 17, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings have been revised on account of non-availability of requisite information. Further it also considers delay in debt servicing as recognized from publicly available information i.e., auditor's comments in the FY22 annual report available from ROC Filings.
