Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 09, 2023, placed the rating(s) of Shirish Hotels Private Limited (SHPL) under the 'issuer non-cooperating' category as SHPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. SHPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated January 23, 2024, February 02, 2024, February 12, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The company is engaged in hospitality business and offers services in the area of restaurants, bar, banquet hall, rooms, and coffee shop. Mr. Yugandhar Dande is also the proprietor of "Shirish Hotels (SH)" under which the proprietor runs a hotel located at Panjagutta, Hyderabad. SH is engaged in bar & restaurants. Currently, the company is managed by Mr. YugandharDande and his son Mr. Shanmug Shirish who looks after overall operations of the company.
