### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 13, 2023, placed the rating(s) of Ocean Healthcare Private Limited (OHPL) under the 'issuer non-cooperating' category as OHPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. OHPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated January 27, 2024, February 06, 2024, February 16, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The company started trial productions in December 2015 with commercial productions from April 2016. OHP is engaged in manufacturing of pharmaceutical formulations which are available in multiple dosage forms including tablets, capsules, gels and dry powder.
