# Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 17, 2023, placed the rating(s) of Fusion Building Materials(Vizag) Private Limited (FBMPL) under the 'issuer non-cooperating' category as FBMPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. FBMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated January 31, 2024, February 10, 2024, February 20, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Fusion Building Materials (Vizag) Private Limited (FBMPL) was incorporated on November 20, 2017 by Dr. Suresh Babu Sadineni (Managing Director) and Ms. Ramanamma Sadineni. The company is primarily engaged in manufacturing of Autoclaved Aerated Concrete (ACC) Blocks of various dimensions and sizes and the same is sold under the brand name 'Fusion Blocks'. The company has set up its manufacturing unit with an installed capacity of 1,00,000 Cubic Meter (M3) per annum at Yerravaram village line, near Visakhapatnam, Andhra Pradesh which commenced operation from August 01, 2019.
