## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 16, 2023, placed the rating(s) of Ashvi Developers Private Limited (ADPL) under the 'issuer non-cooperating' category as ADPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. ADPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated January 30, 2024, February 09, 2024, February 19, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Incorporated in 2006, Ashvi Developers Pvt. Ltd. (ADPL) along with another company Atithi Builders and Constructors Pvt. Ltd. (ABCPL) of Ariisto Realtors group is developing a real estate project "Ariisto Sommet" (erstwhile named as Ariisto Solitaire) at Goregaon, Mumbai. The group has developed an area of 68.12 lakh square feet (Isf) till date which includes super-premium residential towers, affordable housing townships, luxurious retail spaces and TDR generating rehab projects in and around Mumbai.
