### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 24, 2023, placed the rating(s) of S. N. Polymers Private Limited (SNPPL) under the 'issuer non-cooperating' category as SNPPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. SNPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated January 10, 2024, January 20, 2024, January 30, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SNPPL have been revised on account of non-availability of requisite information.

SNPPL was incorporated in the year 1986 for setting up a manufacturing unit of PVC pipes and other allied product. The manufacturing unit of SNPPL is located at Jalpaiguri, West Bengal with an installed capacity of 4,032 tons per annum. Further, to diversify its business profile, the company also started executing various work contracts services like tube well drilling and other irrigation work for various government departments. The company mainly executes orders for tube well drilling and other irrigation works mainly for West Bengal State Government and Central Government.
