### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 16, 2023, placed the rating(s) of Srinivasan Associates Private Limited (SAPL) under the 'issuer non-cooperating' category as SAPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. SAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated January 30, 2024, February 09, 2024, February 19, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Srinivasan Associates Private Limited was originally established as 'Srinivasan Associates' by Mr. G.Srinivasan in 1987, as a proprietorship firm engaged in construction of residential and commercial buildings on contract basis. Subsequently in 2006, the constitution was changed to a private limited company under the name 'Srinivasan Associates Private Limited' (SAPL). Mr. G.Srinivasan and Mrs.S.Malarvizhi (wife of Mr. G.Srinivasan) are the directors. The company is ISO 9001:2008 certified. SAPL has executed projects across Tamilnadu, Andhra Pradesh, Karnataka and Haryana and is presently concentrating in projects in Tamilnadu (Coimbatore, Madurai and Chennai). SAPL is also engaged in manufacturing of flyash bricks which is used for captive purpose.
