Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 28, 2023, placed the rating(s) of Cochin Frozen Foods (CFF) under the 'issuer non-cooperating' category as CFF had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. CFF continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 13, 2024, March 23, 2024, April 02, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Cochin Frozen Foods (CFF) is engaged in processing and exporting of seafood, primarily prawn and fish varieties with its corporate base in Aroor, 15 kms to the south of Cochin. The firm is promoted by Mr. K. Prabhakaran who in the field of seafood exporting from the year 1974. CFF normally exports its entire produce to the major markets of USA, Vietnam, Europe, Japan, China and the Middle East.
