Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 23, 2023, placed the rating(s) of Sri Rama Ginning Industries (SRGI) under the 'issuer non-cooperating' category as SRGI had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. SRGI continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 07, 2024, April 17, 2024, April 27, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Though SRGI was established in 2016, it started its commercial operations from October 2017.
