## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 10, 2023, placed the rating(s) of Tolaram Surendra Kumar Kundalia (TSKK) under the 'issuer non-cooperating' category as TSKK had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. TSKK continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated February 24, 2024, March 05, 2024, March 15, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of TSKK have been revised on account of non-availability of requisite information.

However, TSK was converted into partnership firm as per partnership deed dated December 06, 2014 and currently managed by Mr. Surendra Kumar Kundalia and his mother Mrs. Tara Devi Kundalia. Since inception, the firm has been engaged in trading of food grains, edible oil, salt, milk, ghee, pulses and other allied products. TSK has added cattle feed, poultry feed in its product portfolio. The firm is operating through a single store located at Jorhat, Assam.
