Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 23, 2023, placed the rating(s) of Sri Sai Poultry (SSP) under the 'issuer non-cooperating' category as SSP had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. SSP continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 07, 2024, April 17, 2024, April 27, 2024. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The firm plans to take up farming of egg, laying poultry birds (chickens) and trading of eggs, cull birds and their manure. The firm plans to sell its products such as eggs and cull birds to retailers through own sales personnel as well as through dealers.
