Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 19, 2023, placed the rating(s) of Champa Bitumen Hot Mixture Plant (CBHMP) under the 'issuer non-cooperating' category as CBHMP had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. CBHMP continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 03, 2024, April 13, 2024, April 23, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Champa Bitumen Hot Mixture Plant (CBHMP) was established in May 2017 as a proprietorship firm to initiate a Bitumen and Asphalt Mixing unit at Kokrajhar in Assam. During February 2018, the firm has started its commercial operation with an installed capacity of 1,00,000 MTPA. The firm will sell its products to the local construction projects. The day-to-day affairs of the firm are looked after by Mr Sewli Mohilary, proprietor, along with a team of experienced personnel.
