Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 12, 2023, placed the rating(s) of Goyum Screw Press (GSP) under the 'issuer non-cooperating' category as GSP had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. GSP continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 27, 2024, April 06, 2024, April 16, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The firm is engaged in the manufacturing of oil mill machinery, solvent and refinery plant machinery, biodiesel and biofuel machinery like screw oil press, oil extraction machines, filter press machines, steam boiler, industrial shredder etc. at its manufacturing unit in Ludhiana, Punjab with various products having varying installed capacity.
