### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 26, 2023, placed the rating(s) of Vasantha Advanced Systems (VAS) under the 'issuer non-cooperating' category as VAS had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. VAS continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 11, 2024, March 21, 2024, March 31, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

VAS engaged in the manufacture of micro control based electronic controllers, assembling high quality Printed Circuit Boards (PCB) and Coils and is an ISO 9001:2015 & IATF 16949:2016 Certified Company. The lender has confirmed that moratorium for the sanctioned bank facilities has been availed by the company.
