Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 14, 2023, placed the rating(s) of Shonan Engineering Works Private Limited (SEWPL) under the 'issuer non-cooperating' category as SEWPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. SEWPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated February 28, 2024, March 09, 2024, March 19, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The company primarily functions as a civil contractor for various government bodies for fabrication, supply and laying of Mild steel (MS) pipes for water supply, sewerage and irrigation activities. The company is a registered class I contractor with Public Works 3 CARE Ratings Ltd. Press Release Department (PWD) Karnataka, Pune Municipal Corporation (PMC) and for Bangalore Water Supply and Sewerage Board (BWSSB) which enables it to bid for orders of all sizes.
