### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 27, 2023, placed the rating(s) of Essel Ahmedabad Godhra Toll Roads Limited (EAGTRL) under the 'issuer non-cooperating' category as EAGTRL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. EAGTRL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 12, 2024, March 22, 2024, April 01, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Incorporated in 2009-10, EAGTRL is a Special Purpose Vehicle (SPV) promoted by Essel Infra projects Ltd (EIL), which has a 74 per cent stake in the SPV; the rest is held by the China Railway 18th Bureau Group Corporation Ltd. EAGTRL was set up to construct, design, engineer, operate, and maintain the Ahmedabad-Godhra (Gujarat) stretch on National Highway (NH) 59, which spans 117.6 kilometres, on a build-operate transfer (BOT) basis.
