RVE continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 06, 2024, May 16, 2024, May 26, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Vapi - based (Gujarat) RV Enterprise (RVE), a partnership firm was established in 2015 by Mrs. Rekha Myatra, Mrs. Neha Shah and Mr. Satish Shah with the purpose to manufacture decorative, automotive and marine paints. RVE had commenced commercial operations for undertaking this job work from August, 2015 from its manufacturing plant located at Vapi, Valsad, Gujarat with installed capacity of 1,100 metric tons per month (MTPM) as on March 31, 2018.
