### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 10, 2023, placed the rating(s) of K.B. Board Mills LLP (KBML) under the 'issuer non-cooperating' category as KBML had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. KBML continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 25, 2024, April 04, 2024, April 14, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The entity procures the raw material i.e. waste papers from Maharashtra based dealers and sell its final products i.e. paper tubes and paper cones to the customers located at domestic as well as international market. The major export destinations of the entity are Srilanka and Dubai.
