CARE Ratings Ltd. had, vide its press release dated May 17, 2023, placed the rating(s) of Brij Kishore Prasad Exports Private Limited (BKPEPL) under the 'issuer non-cooperating' category as BKPEPL had failed to provide information for monitoring of the rating. BKPEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 01, 2024, April 11, 2024, April 21, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
