Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated May 29, 2023, placed the rating(s) of YCD Industries Limited (YCD) under the 'issuer non-cooperating' category as YCD had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. YCD continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 13, 2024, April 23, 2024, May 03, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings have been revised on account of non-availability of requisite information. Further it also considers significant decline in scale of operations and profitability as well as a leveraged capital structure as a result of increase in overall debt during FY23.
