CARE Ratings Ltd. had, vide its press release dated May 10, 2023, placed the rating(s) of Kaalendi Ventures LLP (KVL) under the 'issuer non-cooperating' category as KVL had failed to provide information for monitoring of the rating. KVL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 25, 2024, April 04, 2024, April 14, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

KV is currently engaged in manufacturing of MS pipes and structural steel products at Fatuha, Patna with installed capacity of 60000 MTPA and 30000 MTPA respectively. Shri Binay Kumar Singh, the Managing Partner, will look after the day to day operations of the entity along with other partners and a team of experienced personnel.
