Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 24, 2023, placed the rating(s) of Platina Steels Private Limited (PSPL) under the 'issuer non-cooperating' category as PSPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. PSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 09, 2024, March 19, 2024, March 29, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Incorporated in June 2011, PSPL is engaged in the manufacturing of stainless-steel rerolling mill with plant located at Thimmapuram, Guntur District, Andhra Pradesh with an installed capacity of 4,200 metric tonnes per annum (MTPA). The company is currently procuring its raw materials from Jindal Steel and Power Limited and Rohit Ferrotech Limited and is supplying through agents to various manufacturing entities.
