Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 15, 2023, placed the rating(s) of IB Valley Transport (IVT) under the 'issuer non-cooperating' category as IVT had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. IVT continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 30, 2024, April 09, 2024, April 19, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

IB Valley Transport (IVT) was constituted as a partnership firm in 1994 by the Agarwal family of Jharsuguda, Odisha. The firm was reconstituted on August 27, 2009 after the expiry of a partner namely Mrs. Pana Bai Agrawal. Currently the firm is being managed by two partners namely, Mr. Nandkishore Agarwal and Mrs. Suman Agarwal. Since its inception, the firm is engaged in handling, loading and transporting of coal. The firm is mainly doing the loading and transporting works for Mahanadi Coalfields Ltd. (MCL), a subsidiary of Coal India Limited. Moreover, the firm has not availed any moratorium from its lender under the RBI regulatory packages.
