### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 11, 2023, placed the rating(s) of Radharaman Cotgin Private Limited (RCPL) under the 'issuer non-cooperating' category as RCPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. RCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated February 25, 2024, March 06, 2024, March 16, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Incorporated in December 2012, Radharaman Cotgin Private Limited (RCPL) was promoted by Mr. Monoj Kumar Biswal and Mr. Adarsh Agrawal. The company has been engaged in manufacturing of ginning and pressing of cotton bales. The manufacturing facility of the company is located at Belpada, Odisha with installed capacity of 2000 quintals per day. RCPL procures cotton from local farmers and agents and sells its products through the wholesalers and distributors located in Punjab, Haryana, Rajasthan, Delhi and Kolkata.
