Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 24, 2023, placed the rating(s) of Sam Industrial Enterprises Limited (SIEL) under the 'issuer non-cooperating' category as SIEL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. SIEL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 08, 2024, April 18, 2024, April 28, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Noida (Uttar Pradesh) based, SAM Industrial Enterprises Limited (SIEL) was incorporated in 1992 as SIRIUS Industrial Enterprises Limited. In 1995 the name changed to the present one. The company was promoted by Mr. Amit Kaka. SIEL is engaged in designing, printing and binding of books such as textbooks, guides for 10th and 12th standard, sample papers, brochures and other printed education material for various boards like Board of High School and Intermediate Education Uttar Pradesh (U.P. Board), National Council of Educational Research and Training (NCERT) and Jharkhand Academic Council (Jharkhand Board).
