Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 11, 2023, placed the rating(s) of Ashtvinayak Leisure Private Limited (ALPL) under the 'issuer non-cooperating' category as ALPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. ALPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 26, 2024, April 05, 2024, April 15, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

Indore (Madhya Pradesh) based Ashtvinayak Leisure Private Limited (ALPL) was incorporated in 2010 by Mr. Anand Goyal along with other family members with an objective to establish a hotel. The hotel facility will be constructed at 4,147.24 sq. meter having total 102 rooms which includes standard, deluxe and suite. Further, the hotel property will have a cafeteria, restaurants and three banquet halls each with capacity of 1000, 800 and 300 persons each. ALPL undertook the project in May, 2015 and envisaged total project cost of Rs.50.90 crore towards the project to be funded through term loan of Rs.20.00 crore, promoter's capital of Rs.25.00 crore and remaining through unsecured loans from promoters and relatives. The company was expected to start its operations from December, 2019.
