Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated June 02, 2023, placed the rating(s) of Kailash Rice And General Mills (KRGM) under the 'issuer non-cooperating' category as KRGM had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. KRGM continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 17, 2024, April 27, 2024, May 07, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The firm is engaged in processing of paddy at its manufacturing facility located in Kaithal, Haryana with an installed capacity of 26,280 tonnes per annum as on December 31, 2019. Furthermore, the firm is also engaged in trading of rice.
