Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 15, 2023, placed the rating(s) of Castings India Private Limited (CIPL) under the 'issuer non-cooperating' category as CIPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. CIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 30, 2024, April 09, 2024, April 19, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of CIPL have been revised on account of non-availability of requisite information. The revision also factored in reported operating as well as net loss in FY23.

Castings India Private Limited (CIPL) was initially set up as a partnership firm in 1974 by the Sharoff family based out of Jharkhand and the same was converted into private limited company in March 1996. Currently the company is managed by Mr. Surendra Kumar Shroff and Ms. Mina Shroff. Since its inception the company has been engaged in manufacturing rolled iron, MS flat angles, MS sections, TMT bars, rods, Hot rolled sheets, guide channels etc. The manufacturing facility of the company is located at industrial area, Saraikela, Kharanwan, Jharkhand.
