Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 11, 2023, placed the rating(s) of Premium Harvest Limited (PHL) under the 'issuer non-cooperating' category as PHL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. PHL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 26, 2024, April 05, 2024, April 15, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Incorporated in April 2004 by the Baheti brothers – Mr. Rajendra Baheti, Mr. Govind Baheti and Mr. Rajesh Baheti, Premium Harvest Limited [PHL, erstwhile Premium Harvest Private Limited (PHPL), converted into a public limited company in October 2010] is engaged in processing & trading of pulses, processing of wheat and milling of wheat flour at its processing facilities located at Khargone in Madhya Pradesh and Delhi. The resultant products, viz. processed pulses, processed and milled wheat flour, are in-turn sold to the wholesalers, retailers & exporters of food items from various parts of India. On the other hand, the raw pulses and wheat are procured directly from various farmers and also from the traders of various agro-commodities.
