## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 11, 2023, placed the rating(s) of Mother Lam Private Limited (MLPL) under the 'issuer non-cooperating' category as MLPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. MLPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 26, 2024, April 05, 2024, April 15, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Ahmedabad-based (Gujarat), Mother Lam Private Limited (MLPL) was incorporated in January 2012 by Mr. Mahesh Patel, Mr Kantilal Patel and Mr Rajesh Gothi. The company is engaged in the manufacturing of decorative residential and industrial laminates which is used as an overlay over plywood or other wooden furniture. MLPL commenced its manufacturing operations from June 2013 onwards, from its sole manufacturing plant situated in Sabarkantha (Gujarat). MLPL caters mainly to domestic demand and markets its product under its flagship brand "NOCTE Lam".
