#### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 08, 2023, placed the rating(s) of G.K. Sales Corporation (GSC) under the 'issuer non-cooperating' category as GSC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GSC continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 23, 2024, July 03, 2024 and July 13, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
