### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 28, 2023, placed the rating(s) of Shreeji sales corporation (SSC) under the 'issuer non-cooperating' category as SSC had failed to provide information for monitoring of the rating. SSC continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 12, 2024, June 22, 2024, July 02, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

SSC was established as proprietorship firm in 2012 by Mr Bharat Shah. SSC was established for trading of di-calcium phosphate and mono-calcium phosphate. SSC is recently completed project of manufacturing di-calcium phosphate and mono-calcium phosphate from raw phosphate instead of trading with total project cost of Rs. 4.64 crore. The plant will be located at Vadodara (Gujarat) with area of 1 lakh sq. ft. with proposed installed capacity of 300 tonnes per month.
