Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 10, 2023, placed the rating(s) of Metal Extrusions (ME) under the 'issuer non-cooperating' category as ME had failed to provide information for monitoring of the rating. ME continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 25, 2024, June 04, 2024, June 14, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Currently, the firm is engaged in wholesale and retail trading of ferrous and nonferrous metals like Aluminium extrusions, Aluminum Rolling sheets & Plates Copper, Brass, Sheet Metals, etc. The firm has its customer base all over country and major customers are Marine Electricals (India) Pvt Ltd and Arrow Engineers. The firm purchases 65% - 70% of raw materials from Hindalco Industries Limited and Jindal Aluminium Limited.
