### Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated June 13, 2023, placed the rating(s) of A & A Modular Systems (AAMS) under the 'issuer non-cooperating' category as AAMS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AAMS continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 28, 2024, May 08, 2024 and May 18, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
