### Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated July 27, 2023, placed the rating(s) of Aditya Auto Industries (AAI) under the 'issuer non-cooperating' category as AAI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AAI continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 11, 2024, June 21, 2024 and July 01, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
