Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 27, 2023, placed the rating(s) of Shanti Parboiling Industries (SPI) under the 'issuer non-cooperating' category as SPI had failed to provide information for monitoring of the rating. SPI continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 11, 2024, June 21, 2024, July 01, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

SPI was established in July 1993 as a partnership firm to set up a rice processing & milling unit and sale of its by-products like husk, bran etc. in the domestic market. The plant is situated at Tatibandh in Raipur District Chhattisgarh, a major paddy growing area and is in close proximity to local grain market enabling easy paddy procurement.
