## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated June 09, 2023, placed the rating(s) of SLEC Infra Projects Private Limited (SIPPL) under the 'issuer non-cooperating' category as SIPPL had failed to provide information for monitoring of the rating. SIPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 24, 2024, May 04, 2024, May 14, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

SLEC Infra Projects Private Limited (SIPPL) was initially established as a partnership firm in the year 1992 under the name of Sri Laxmi Engineering Company. The name of firm was changed to SLEC Infra Projects in February 2013. Later in July 2013, SLEC Infra Projects has been reconstituted as a private Limited Company and currently managed by Shri K. Rama Rao (Managing director) along with three other directors. SIPPL is engaged in civil construction services with major focus on irrigation projects in Telangana. The company is registered as a special class contractor with the Govt. of Andhra Pradesh (AP) and has executed projects mostly for the Govt. of A.P (united Andhra Pradesh). The Company is currently executing irrigation projects from Telangana Irrigation Department, Development works of Endowments department, Nizamabad and raising of ash pond for TSGENCO.
