### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated July 17, 2023, placed the rating(s) of Windsor Industries Private Limited (WIPL) under the 'issuer non-cooperating' category as WIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. WIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 01, 2024, June 11, 2024 and June 21, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Windsor Industries Private Limited (WIPL) is promoted by Mr. P S Sahni, a first-generation entrepreneur who is the Managing Director of the company and is engaged in this industry since 1989 through various entities promoted by him. WIPL is engaged in the manufacturing of expanded polystyrene (EPS) packaging goods, insulation sheets, disposable crockery (plate s, cups, bowls, etc.) in various shapes and sizes, Bio -degradable crockery and BoPP (biaxially oriented polypropylene) Self Adhesive tapes and sells under the 'Windsor' brand in domestic market. The company has its units located at Kurali, Punjab and Baddi , Himachal Pradesh.
