## **Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated July 26, 2023, placed the rating(s) of Chaudhary Agro Foods Industry (CAFI) under the 'issuer non-cooperating' category as CAFI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CAFI continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 10, 2024, June 20, 2024 and June 30, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
