Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated June 01, 2023, placed the rating(s) of J J Hi Tech Foods Private Limited (JJHTFPL) under the 'issuer non-cooperating' category as JJHTFPL had failed to provide information for monitoring of the rating. JJHTFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 16, 2024, April 26, 2024, May 06, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

J J Hi Tech Foods Private Limited (JJHTFPL) was promoted by Mr. Ravi and Ms. Parvathi in November, 2011 for processing of paddy with the installed capacity of 120 MT per day in Manachallur, Trichy. The commercial operations of the company commenced from February 01, 2014. Paddy is the main raw material which is procured from the farmers based in Tamil Nadu (mainly in and around Trichy), and through traders in Andhra Pradesh and Karnataka.
