CARE Ratings Ltd. had, vide its press release dated June 09, 2023, placed the rating(s) of C K Fabrics Private Limited (CKFPL) under the 'issuer non-cooperating' category as CKFPL had failed to provide information for monitoring of the rating. CKFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 24, 2024, May 04, 2024, May 14, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

C K Fabrics Private limited (CKFPL) was incorporated in 2012 by Mr L. Rajesh, Ms L. Sita, Ms L. Sunitha, Mr Y. Suresh and Mr L Sai Krishna as a private limited company. The company is engaged in manufacturing of polypropylene spun bonded non-woven fabric and bags. It commenced its operations during September 2014 at its processing facility at Rangapur area in Kothur (Telangana). The installed capacity stood at ~2,300 metric tonnes per annum.
