### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated June 29, 2023, placed the rating(s) of Bhimashankar Agro Coldchain & Processingproducer Company Limited (BACPCL) under the 'issuer non-cooperating' category as BACPCL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BACPCL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 14, 2024, May 24, 2024 and June 03, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
