Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated June 01, 2023, placed the rating(s) of Bidar Solar Power Private Limited (BSPPL) under the 'issuer non-cooperating' category as BSPPL had failed to provide information for monitoring of the rating. BSPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 16, 2024, April 26, 2024, May 06, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Bidar Solar Power Private Limited (BSPPL), is a special purpose vehicle (SPV) sponsored by GKC Projects Ltd (GKCPL) for setting up Solar PV (Photovoltaic) power plant in the Bidar district of Karnataka on Design, Build, Finance, operate and Transfer (DBFOT) basis. The installed capacity of the plant is 10 MW. The project has achieved commercial operational date (COD) on August 28, 2014.
