Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 27, 2023, placed the rating(s) of Sri Gopal Auto Center (SGAC) under the 'issuer non-cooperating' category as SGAC had failed to provide information for monitoring of the rating. SGAC continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 11, 2024, June 21, 2024, July 01, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

Andhra Pradesh based, Sri Gopal Auto Centre (SGAC) was incorporated in the year 1993 as a Proprietorship firm by Mr.D. Pundarikakshaya (Proprietor). The firm is an authorized dealer of Hero Motor Corp Limited -HMCL. The firm is engaged in sale of two-wheelers and spare parts as well as servicing of vehicles. The vehicles sold by SGAC are Motorcycles and Scooters (covers around 18 models). The firm derives 95% of the revenue from sale of vehicles and remaining 5% from sale of spare parts and the services rendered by the firm to its customers.
