Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 11, 2023, placed the rating(s) of Biosynergy Lifecare Private Limited (BLPL) under the 'issuer non-cooperating' category as BLPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BLPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 26, 2024, June 05, 2024 and June 15, 2024. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information

which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Uttar Pradesh based Biosynergy Lifecare Private Limited (BLPL) was incorporated as a private limited company in the year 2016 and started its commercial operations in August 2018. The company is currently being managed by Mr. Raghav Mittal, Mr. Sachin Maheshwari, Mr. Rishabh Maheshwari, Mr. Mukund Kela and Mr. Harshit Aggarwal. The company is engaged in manufacturing of pharmaceutical bottles of IV(Intravenous) foods which are based on FFS (Form Fill Seal) and BFS (Blow Fill Seal) Technology wherein bottles are processed, filled and sealed inside the machine without any human intervention, thus ensuring complete sterility of the liquid filled
